# **Migration Case Study**

Gloucester based GCC Innova has chosen Exchequer Dynamics to help migrate Lincoln Castle Academy (formerly Yarborough School) to Sage 200. Lincoln Castle Academy are one of the oldest Exchequer customers who can remember dealing with the founder directors of Exchequer; Eduardo Loigorri and Robert Steele before Iris acquired Exchequer in 2005. As an academy they have made the decision to move from Exchequer because the software didn't give the academy the flexibility it wanted within a manageable budget.



Having won the bid to migrate the customer to Sage 200, GCC Innova contacted Exchequer Dynamics to help with the extraction of the data from Exchequer. Exchequer Dynamics used the ExSync its data extraction tool migrate the required data from two companies into a Microsoft SQL server. Once extracted we provided consultancy to format it ready to be queried and imported into Sage 200.



The night before the go live date we re-ran the extraction ready for a final import before the new dawn of Sage 200 for Lincoln Castle Academy.

UN/EDIFACT (the United Nations rules for Electronic Data Interchange for Administration, Commerce and Transport) are a set of internationally agreed standards, directories, and guidelines for the electronic interchange of structured data, between independent computerised information systems.

Across the retail and distribution markets EDIFACT is being adopted as the preferred and sometimes <u>only</u> acceptable EDI (electronic data interchange) standard for transmission of orders and invoices. It is rapidly replacing XML and becoming the industry standard for unified EDI messaging. All of the major supermarkets and retailers in the UK require suppliers to transmit and receive EDIFACT messages. So if you are a business looking to trade with such companies EDIFACT will be something you need to consider.

There are good reasons why a company may choose to locate their IT infrastructure in a data centre, one being that they don't have any physical space to house the servers and storage they need. 

#### Searching In Exchequer.

There are a number of search tools which can be used in Exchequer if unsure of a code when entering and searching for transactions, stock records and more.

All of the below are used within transactions. If using F8 search, ignore the symbol characters described and just choose the text you are looking for and the appropriate field.

Any text field - entering any set of text preceded by "\*\*" (two asterisks), e.g. entering '\*\*Green' will search for any records containing the word "Green".

Alternative Code – entering part (or all) of an alternative code preceded by the "?" will search for codes containing that text on customer, stock or supplies.

#### Alternate Database Code -

- Enter either part or all of the code preceded by a ">" to search all alternate database codes.
- Enter part/all of the code preceded by a "!" for a controlled list only linking to the current customer/supplier.

**Bar Code** – Enter a bar code using '<' as a prefix when searching stock records. **Description** – Enter the "/" character followed by part or all of the description. **Stock/Account/Employee Code** - enter part or all of the code.

#### Searching on the General Ledger -

The search tools explained above to do not work within the G/L Find Facility. If you wish to search in this manner you can search by entering the full G/L code or he first few letters of the G/L description.


